AYURVEDA REVENUE for Q3 of FY 2008-09 GREW BY 31%

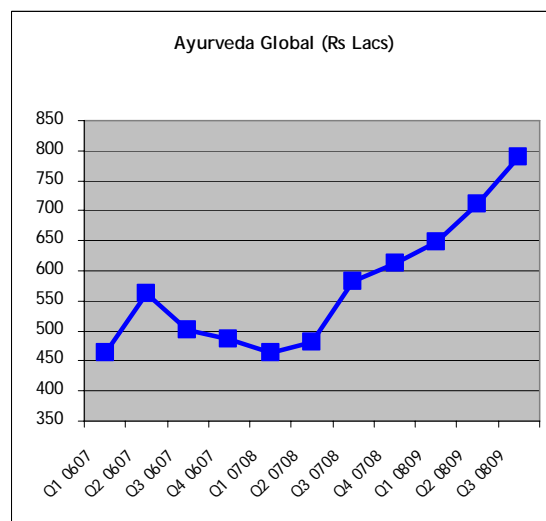
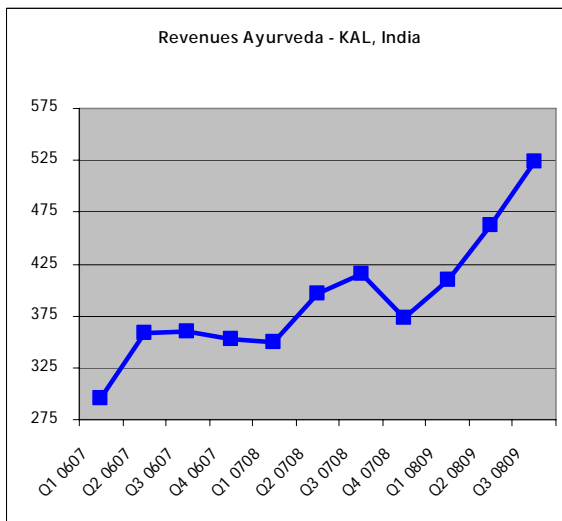
CONSOLIDATED REVENUES CROSSED RS. 10 CRORES FOR 3rd SUCCESSIVE QUARTER
