 The Board has approved the issue of upto 5,55,000 (Five Lakhs Fifty-Five Thousand Only) Equity Shares of face value Rs. 10/- (Rupees Ten Only) each ("Equity Shares") for cash at a price Rs. 125.21/- (including a premium of Rs. 115.21/- per Equity Share) for an amount upto Rs. 6,94,91,550 /- (Rupees Six Crores Ninety-Four Lakhs Ninety-One Thousand Five Hundred and Fifty only) to the below mentioned Promoter group, ("Proposed Allottee"), on a preferential basis ("Preferential Issue") in accordance with Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI (ICDR) Regulations"), as amended, subject
